

# A Bibliography of Pharmacy Administration Master's Theses and Doctoral Dissertations Relating to Education 1993-2000

The following list contains master's theses and doctoral dissertations related to education within the discipline of pharmacy administration for the period 1993 to 2000. This list begins where the previous list of master's theses and doctoral dissertations work in pharmaceutical marketing and management for the period 1985 to 1992 left off (*Journal of Marketing and Management*, Vol. 8(1) 1994 by David J. McCaffrey III and Lisa Ruby Basara). The theses and dissertations for this publication were obtained through a survey of pharmacy schools having graduate programs in pharmacy administration. Missing information for dissertations was found using *Dissertation Abstracts Online*.

We were unable to obtain a complete list of theses and dissertations from all pharmacy schools offering graduate programs in pharmacy administration. Some schools chose not to participate. Other schools did not send any information or did not have the information available for inclusion. For these reasons, this bibliography is not all-inclusive nor is it intended to serve as a thorough compilation of all pertinent records; it could, however, serve as a useful list of research efforts in the field of
